We had a general Committee observation, that the Committee having considered the nominee's filled Questionnaire, pursuant to Section 7(8) of Public Appointment (County Assemblies Approval) Act No. 5 of 2017 Act No. 5 of 2017, their Curriculum Vitae and having heard their oral submission during the vetting exercise/interview, made the following observations on their suitability for appointment as Chairperson and Members of Isiolo Municipal Board;

1. That, they satisfy the requirements of Chapter 6 of the Constitution of Kenya on leadership and integrity having been cleared by the Kenya Revenue Authority, Higher Education Loans Board (HELB), Ethics and Anti-Corruption Commission and the Credit Reference Bureau.
